**Part 1****Numbering of Buildings****§4-101. Building Numbering System Adopted.**

A plan and system for the numbering of houses and buildings prepared by the Borough Council is hereby approved and adopted.

**§4-102. Responsibilities for Numbering Buildings.**

On and after the passage and approval of this Part, it shall be the duty of each and every owner, trustee, lessee, agent, and occupant of each and every house, building or other structure in the Borough to cause the same to be numbered in accordance with this Part, and the system and plan hereby adopted and approved.

**§4-103. Requirements for Numbers.**

1. The numbers shall be placed in a conspicuous place on or over each front door, or the front transom bar, front transom or front show windows, over or on either side of the entrance, the same number to be of paint, metal, or enamel, and at least 3 inches in height, the color of the numbers to be in contrast to the immediate background, and shall be so placed as to be in full view from the opposite side of the street.

2. It shall be unlawful to cover any house number with any sign, drapery, or other obstruction tending to conceal such number.

3. The Borough Council is hereby authorized to require the numbering of any house, building, or other structure in accordance with this Part.

**§4-104. Numbering System.**

The numbering system shall be based on increments of  $\frac{1}{1000}$  of a mile. Numbers are then determined and assigned by dividing the footage from the beginning of the street to the building by 5.28, and adding, the prefix determined by the number of miles from the beginning of the street (i.e., if the place to be addressed is 3,263 feet from the second mile from the beginning of the street, 3,263 is divided by 5.28, which equals 618. Adding the 2, the number of miles from the beginning of the street, the number is 2618 or 2617 if on the odd side of the street).

**§4-105. Penalties.**

Any person, firm, or corporation who shall violate any provision of this Part, upon conviction thereof in an action brought before a magisterial district judge in the manner provided for the enforcement of summary offenses under the Pennsylvania Rules of Criminal Procedure, shall be sentenced to pay a fine of not more than \$1,000 plus costs and, in default of payment of said fine and costs, to a term of imprisonment not to

exceed 90 days. Each day that a violation of this Part continues or each Section of this Part which shall be found to have been violated shall constitute a separate offense.
