# ORDINANCE NO. 2014-2

An ORDINANCE of the Council of The Borough of Nesquehoning, Carbon County,
Pennsylvania, Amending the CODE OF ORDINANCES OF THE BOROUGH OF
NESQUEHONING Chapter 15 Section 904 and known as the SNOW EMERGENCY NO
PARKING and adding a new section to Chapter 15 Section 904.1 entitled SNOW PLOWING
BY PRIVATE OPERATORS.

### Section 904: Snow Emergency No Parking.

In accordance with the provisions of Chapter 15, upon a snowfall, the following streets or parts thereof are hereby designated as snow emergency no parking areas until the area is plowed:

### **Section 904.1** Snow Plowing by Private Operators

A. No person, firm or corporation shall be permitted to plow the streets or alleys of the Borough of Nesquehoning so as to leave an accumulation of snow and/or ice within the streets or alleys of the Borough., unless permission has been sought from and approved by the Borough Council.

B. No person, firm or corporation shall be permitted to pile, gather up, plow up or in any way force any snow or ice upon any street, alley, or roadway within the Borough of Nesquehoning or from one street, alley or roadway onto any other street, alley or roadway within the Borough.

C. No person, firm or corporation shall be permitted to plow any snow and/or ice across any street, alley or roadway of the Borough of Nesquehoning from any type of private property including but not limited to private driveways, etc. thereby leaving an accumulation of snow and/or ice across a street, alley or roadway of the Borough.

D. Whenever any person, firm or corporation violates the provisions of this ordinance and engages in plowing of snow either on Borough streets or roadways, across Borough Streets or roadways, or from private property onto Borough streets or roadways, the person engaging in such plowing in violation of the provisions of this ordinance shall be notified either by the Chief of Police, the Mayor, any council person, the Borough Secretary or any agent so designated by

the Borough Council to remove the snow plowed onto or across the Borough Streets, alleys or roadways within four (4) hours of said notice. In the event that the violator does not remove the snow plowed onto or across any Borough Street, alley or roadway, then the Borough work crew may remove said snow and/or ice and the cost of such removal will be assessed against the person, firm or corporation in violation of this ordinance.

D. In the event that such a bill for the costs of removal of the snow and/or ice from the Borough streets, alleys or roadways is not paid within thirty (30) days of issuance, then the Borough may impose a lien against the real property of the person, firm or corporation performing the snow plowing.

E. Any person, firm or corporation violating the provision of this ordinance shall be subject to a fine of Twenty-Five dollars (\$25.00) for a first offense. In the event of a second offense within any six month period of time then and in that event the violator shall be subject to a fine of one hundred dollars (\$100.00). For any third or subsequent offense, the violator shall be subject to a fine of Three hundred dollars (\$300.00). Any violator shall also be subject to be ordered to fully reimburse the Borough for the costs of the removal of the snow and/or ice together with any costs associated with the collection of said monies including but not limited to administrative fees and attorney fees.
