

ORDINANCE NO. 2020-3

AN ORDINANCE OF THE COUNCIL OF THE BOROUGH OF NESQUEHONING, CARBON COUNTY, PENNSYLVANIA, AMENDING THE CODE OF ORDINANCES OF THE BOROUGH OF NESQUEHONING, SECTION 15-402 AND KNOWN AS PARKING PROHIBITED AT ALL TIMES

BE IT ORDAINED and Enacted by the Council of the Borough of Nesquehoning as follows:

Section 15-402 PARKING PROHIBITED AT ALL TIMES.

1. Parking shall be prohibited at all times in the following locations:



Allen Street	East	High Street to Railroad Street
Allen Street	Both	Railroad Street to Willow Lane
DaVinci Alley	Both	From Milan Avenue to Padua Avenue
Garibaldi Avenue	South	From Messina Avenue to Padua Avenue
Marconi Avenue	Both	From Messina Avenue to Padua Avenue
Marconi Avenue	Both	From Angelini Avenue to Pastore Avenue
Market Street	East	From Catawissa Street to Allen Street
Mill Street	South	From School Street to Mermon Avenue
Orchard Lane	South	From Spruce Street east to Walnut Street
Ratcliff Street	West	From Catawissa Street to Mill Street
School Street	West	From High Street to Railroad - Center Streets
School Street	West	From Catawissa Street to Mill Street


School Street	East	From Railroad/Center Street to Catawissa Street
Tippetts Road	Both	From the Intersection of Tippetts Road and Stock Street to the entrance to Lake Hauto development
East Catawissa Street	North	From Hunter Street(SR 0093) to 300 feet West of the intersection with Hunter Street (SR 0093)
Hunter Street	West	From East Catawissa Street (SR 0209) to 250 feet north of the intersection with East Catawissa Street (SR 0209)
Ratcliff Street	Both	From Catawissa Street to Railroad Street
High Street	South	Allen Street to Mermon Avenue
Mill Street	South	Mermon Avenue to Hazard Street
Industrial Road	Both	Park Avenue to Dennison Road
East Railroad Street	South	Spruce Street to Cul de Sac turnaround
Little Flower Avenue	Both	from Pastori Avenue to Cul de Sac turnaround

As to all other matters Section 15-402 of the Borough Code is hereby ratified and this Amendment shall be effective immediately upon adoption.
